IV. SUPERINTENDENT TOP HAPPENINGS

Ms. Lorah Neville, Superintendent, presented the governing board with the top happenings around the district.

- 1. The 2016-2017 District Kick-off was Friday August 5th. All employees who were on contract, met at the Dos Rios Multi-Purpose Room to share a wonderful breakfast and start the year off as a team. Teams of teachers, educational support staff, and administrators discussed why we are here and what our purpose is. We reviewed the mission and vision of the district which aligned to the reasons everyone identified for being here. We learned a little from Mr. Rogers https://vimeo.com/99087518 about the importance of our work and working as a team for Union students and families.
- 2. Dos Rios did have an awesome turn out for Open House/Meet the Teacher Night. There were a lot of positive comments about the new teachers. The first three days of school has been amazing!!! Our teachers are establishing positive relationships with kids through team building activities and small groups. Overall positive vibes all over campus!
- 3. The Super Star team at Hurley Ranch engaged an outstanding first week back to school. Collaboratively, each team at Hurley Ranch created a purpose statement answering the question, "Why are we here?" During this process, the Super Star grade level teams bonded and shared the same sense of pride with their profession and commitment to our students. - 4. Union Elementary School is off to a great start! Teachers are establishing classroom procedures and practicing these procedures so that they become routines. How to get students' attention non-verbally, how to move around the classroom, how to get materials, how to appropriately interact with peers, and how to walk in the hallways are just a few. 100% compliance is key! This will ensure student safety and maximize instructional time. Students have also been engaged in team building and culture building activities in order to establish a positive, respectful classroom culture in our classrooms. Teachers are working closely together in their grade level teams to develop objectives, plan lessons, and learning checks around the strategic instructional design model to ensure high quality, differentiated instruction.
- 5. In the 2014-2015 school year, Union School District had 9 students that were identified for retention by the law and did not qualify for an exemption. In the 2015-2016 school year, we had only 5 students identified who did not qualify for an exemption. In response, the students were offered summer school as an intervention and 3 of the 5 students demonstrated sufficient growth to be promoted to 4th grade. Therefore, we only have 2 students district wide that were retained in 3rd grade due to the MOWR law going into the 2016-2017 school year. A presentation on the district's MOWR plan will be presented to the Board at the September Governing Board meeting.
