V. SUPERINTENDENT TOP HAPPENINGS

Lorah Neville, Superintendent presented the governing board with the top happenings around the district.

- 1. Union Elementary hosted their 2nd Annual Family Spring Carnival on Saturday, April 8th, from 11am-2pm. Families enjoyed several inflatables, a dunk tank, carnival games, food, music, Folklorico dancers and even a cake walk. This event was well attended. Fry's Foods donated over 280 bakery items for our cake walk and the event was supported by many volunteers including: Union staff, Union families, Glendale Community College students, and Tolleson Union High School students.
- 2. Hurley Ranch Elementary 4th grade team of teachers worked hard to ensure that their annual egg hunt was a hit. Based on the response from both students and parents, they knocked it out of the park. Every student came away with multiple eggs filled with candy. This was part of their monthly incentive for appropriate behavior and the students' best efforts in the classroom. Every grade-level has been charged with designing an incentive plan for students targeting positive behavior and academics. Additionally, we have designed school-wide goals tied to incentives for students, including grade-level rewards for behavior in the cafeteria. These goals are expected to be communicated to students, posted in prominent locations, and updated on a consistent basis. Three of our grade-levels received an ice cream treat for

reaching their goal in the cafeteria with 7^{th} grade leading the way having accumulated the most days of outstanding behavior.

- 3. Dos Rios Elementary fourth graders with the assistance of Ms. Vail arranged were able to observe an *Every Kid in a Park* presentation from the Bureau of Land Management. Our softball and baseball teams had their last home games of the season and have shown a ton of growth and improvement over the season! A huge thank you to our baseball coach Mr. Steck and our softball coaches Ms. Mercado and Mr. Davis! Our kindergarten students participated in a gigantic egg hunt after they learned all about eggs and what happens to them when submerged in different liquids. A large amount of our Dos Rios students auditioned for the talent show that is taking place on Thursday, April 20th and apparently we have a ton of Dos Rios talent on campus! Miss Solky is back from maternity leave and we are so happy to have her back! Mrs. Daugherty (our mentor teacher) is videotaping our new teachers so that they are able to reflect on their instruction together and the new teachers are able to observe themselves teaching in an effort to refine their instructional practice. Our 6th, 7th, and 8th graders are participating in Touchstone classes to increase their understanding of different life topics relevant to their age.

Most notably, there were no reported incidents during testing. Kudos to teachers for the diligence ensuring a smooth test administration. Both our ELA and math PLCs have resumed.
